SUHSD Contractor Pre-qualification Scoring Policy

The pre-qualification of contractors for projects greater than \$1,000,000 will be evaluated in two parts. The first part of the pre-qualification evaluation will be provided to the Salinas Union High School District through the Quality Bidders'™ online application process as outlined below. The District will use the results provided from Quality Bidders™ and further pre-qualify the size of projects allowable for each contractor. This procedure outlines both the Quality Bidders™ pre-qualification scoring guide and the District's further project size assignments to be used for all applicants requesting pre-qualification with the District.

QualityBidders

PART I: Quality Bidders Scoring Summary

To conduct pre-qualification of contractors, California requires the district school board to adopt a uniform rating system. The Quality Bidders application produces a score that can be used, along with financial statements, reference checks, and added district requirements, to aid and facilitate whatever uniform rating system the school board adopts.

The Quality Bidders application is a five-step questionnaire:

- Step 1 is contractor information, certifications, and qualifications.
- Step 2 is general requirements. Answers are scored.
- Step 3 is history and performance. Answers are scored.
- Step 4 is recently completed projects and references.
- Step 5 is additional district requirements and certification/declaration that the responses are true and correct.

Only completed applications can be submitted.

PART II: ESTABLISHMENT OF PROJECT SIZE CONTRACTORS PRE-QUALIFIED UP TO

Step 1: Financial Solvency Evaluation.

Calculate the contractor's *Quick Ratio* from most recent financials. The quick ratio is calculated by adding cash, cash equivalents, short-term investments, and current receivables together then dividing them by current liabilities. Also known as the Acid Test.

Step 2: Evaluate contractor's overall past performance for establishing future pre-qualified award limits.

Use applicant's percentage of total score achievable from the Quality Bidders' questionnaire to determine which project valuation to use in establishing the value of projects a contractor will be prequalified to perform up to. Note: A contractor must achieve at least 75% in order to be eligible to prequalify for projects greater than \$1,000,000.

96%-100%: Highest Public Works Project Listed

90%-95%: Highest School Project Listed 75%-89%: Average of All School Projects

Financials Provided Not Sufficient to Calculate Quick Ratio: Average of All School Projects.

Step 3: Calculate Preliminary Pre-qualified Project Size Limits.

Multiply the firm's Quick Ratio to project information identified in Step 1 above and round-up to the nearest quarter of a million dollars.

Example 1: Application score is 75%. Per Step 1, find average school project value in the application summary and multiply the average school project value by the firm's quick ratio. The results of the calculation yield \$4,036,678. The contractor would be prequalified for projects up to \$4,250,000.

Example 2: Application score is 92%. Per Step 1, review all project data provided and find the highest school project recorded. Multiply the highest school project completed by the firm's Quick Ratio. The calculation yields \$36,523,789. The contractor would be prequalified for projects up to \$36,750,000.

Step 4: Review Bonding Capacity and Finalize Maximum Prequalified Project Size Limit.

Review maximum bonding capacity. Prequalification "up to" amounts cannot exceed the contractor's ability to be bonded.
