INFORMATION ITEMS

Virginia Boyce with the District updated committee members that the District has entered into a lease-lease back agreement with Otto Construction for completion of the Phase II stadium project at Rancho San Juan High School. The project budgeted at \$4.2 million remains within the original budget balances remaining from the Measure B Phase I construction budget.

The District successfully passed Measure W during the general elections in November 2021 providing additional \$140 million that will become available through the sale of bonds. The committee will assume oversight of those funds in addition to the Measure M and Measure B funds remaining once those bonds go up for sale.

With the passage of Measure W, the District is comfortable in moving forward with the new 2-Story Classroom Buildings at all three impacted high school sites at North Salinas, Alisal, and Salinas High Schools. The District is currently in the planning stages for how to prioritize and obtain adequate cost estimates so that the projects will be assigned and tracked through the appropriate bond measure fund. Additionally, administration will be presenting to the Board of Trustees proposed priority projects and timelines for Board approval.

Staff has created a flyer for distribution to parents and the public identifying the need for addition members for the citizen's bond oversight committee which should be made available to the public after administration review.
